

Tell-a-Friend Programme

2007-2008 rules

- **Article 1. Programme's period: the Tell-A-Friend Programme will be effective from 01/07/2007 through 31/12/2008.**
- **Article 2.** The programme is aimed at private customers holding an insurance contract written through the intermediary of Aon InsureXpat.
- **Article 3.** Those customers of Aon InsureXpat who participate in the Tell-A-Friend programme shall be called "sponsors". The individuals sponsored or recommended by those sponsors shall be called "friends".
- **Article 4.** The salaried employees of Aon as well as the members of the sponsor's family living within the same home are not entitled to become friends.
- **Article 5. The friend must be a new client and must contract an insurance policy covering an automotive vehicle through the intermediary of Aon InsureXpat.**
- **Article 6.** The Tell-A-Friend programme consists in a gift certificate in the form of a **bonus check** offered to the sponsor. The offer shall be limited to **5 (five) friends** for one sponsor during the whole period in which the programme will be effective.
- **Article 7.** The **bonus check** shall be for an amount of **€ 20** (twenty euros) and shall be acquired by the sponsor for each sponsored friend (one transaction only for each friend). Where several friends of the same sponsor are resident at the same home, the sponsor will receive one check only. Bonus checks, the total of which may not be greater than **€ 100 (one hundred euros) per sponsor, shall be sent to the sponsor at the end of the period.**
- **Article 8. The Friend shall complete and send the Tell-A-Friend coupon to Aon InsureXpat** (not forgetting the sponsor's name and personal ID number) so that the sponsor may receive the gift.
- **Article 9.** Participation in this programme means for the sponsors full and entire acceptance of the hereby rules and provisions. Any problem in interpreting or understanding the rules shall give rise to written inquiry to Aon InsureXpat who shall provide the necessary explanations and clarifications.
- **Article 10.** Aon France will bear no liability or responsibility whatsoever in the event that, for any reasons beyond the control of same, the Tell-A-Friend programme, including its rules and/or financial offers, should be postponed, amended or cancelled, in whole or in part.
